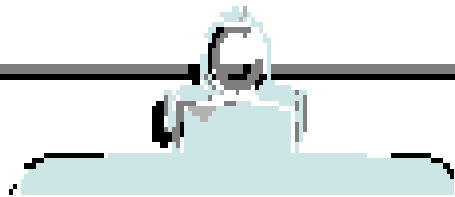

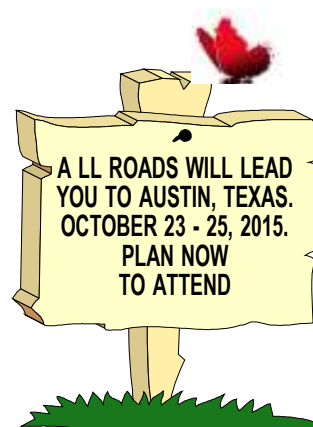
SOUTH CENTRAL FEDERATION'S ANNUAL MEETING:

Looking forward to your submissions and a great contest in 2015!

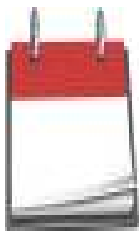

HOLIDAY SAFETY 2014

The Holidays are upon us! What are you doing to help keep yourself and your family safe?

Here are a few things to consider around the Holidays this year.

First... Decorations. Especially for those of us who are not quite spring chickens any more it can be hazardous to do things like crawl in and out of the attic getting decorations, or putting up Christmas lights.

Using smaller boxes to store decorations can be very helpful as we maneuver through our attics, garages and basements. Hernias and slipped disks are NOT the kind of present you want to give yourself this year.

Step ladders are MUCH safer than chairs when setting up decorations inside your home. Considering that you can buy one for \$25 or less at most big box stores they are a great value for safety.

Hanging decorations outside can pose more serious risks. Make sure

you have a spotter whenever you are on a ladder. Over the years I've had several friends who have lost older family members from ladder falls this time of year. And then there are the electrical issues! How many of us are still using those Christmas lights from 1979??? Frayed wires, lack of fuses, overloaded plugs, all have the potential to cause fires or electrocutions! Consider upgrading your lights or going with a more modest presentation. There are also 3rd party services that will put lights up for you if you're willing to pay a little more.

Kitchen safety has a variety of elements to it so without going into too many details if you can make extra time to prepare what you will serve. Things will be a lot less chaotic and thus lessen the chance of things like cuts, burns and scalds.

With the above being said the most dangerous part of Holidays typically revolves around travel. Lots of

people on the roads. Every day I drive an hour each way in and out of downtown Houston for work. I'm used to it, but during the Holidays there are A LOT of people on the roads that are not used to the vagaries of heavy traffic. Consequently driver confusion and fatigue spikes during Holiday travel. Planning your trips and giving yourself extra time to get where you are going will help you minimize your risks. Finally, although we are all aware of it, there will be a lot of folks on the roads who have been drinking alcoholic beverages. The concentration of drunk drivers on our roads peaks after midnight and goes until 4:00 AM. Avoid driving at these hours.

RHODOCHROSITE

The classic color of this mineral is rose-pink, although it can also be brown or gray. It was named in 1800 from the Greek work "rhodokhros" "of rosy color". A manganese carbonate, most samples have some calcium and iron substituting for manganese, some also contain magnesium. It is found in hydrothermal ore veins formed at moderate temperatures, in high-temperature metamorphic deposits, and as a secondary mineral in sedimentary manganese deposits. In Butte, Montana, it is so abundant that it is mined as an ore of manganese. It is found in many countries around the world.

ROCKS, ROVERS, AND ROBOTS..... OH MY!

Let me introduce myself to everyone. My name is Michelle Talcott and I currently live in Jasper, Texas. I am in my third year of teaching Fifth grade science, after a 20 year career as an Environmental Geologist. I have a Bachelor and Master of Science Degree in Geology from Stephen F. Austin State University in Nacogdoches, Texas. I spent many years conducting soil and water monitoring at gas stations, landfills, and various other contaminated sites. I began my teaching career to allow more time with my nine year son, Carter.

As part of our science curriculum, our students are in their second year of participating in a Mars Rover project to develop their own "mission" to Mars. Last year we had 75% participation in this project!



This year I am also the sponsor for a Lego robotics club that is being organized through our local 4H. We have approximately 70 students that are participating after school to build and program the Lego EV3 robots. Our plan is to compete against other schools in the spring.

In October 2014 I also started our local Junior Rock club as an extension of the Pine Country Gem and Mineral Society

in Jasper, Texas. We have had 8-10 students that are really excited to learn, collect, and discuss rocks and minerals.

All of this to say that I have a heart for teaching students about science. I tell my students that "I am a scientist to the core" and that I love science. I feel a responsibility to pass along any knowledge that I have gained to the subsequent generations. I challenge everyone to do the same and pass along some of your knowledge to others.

Through this column I want to write about the student activities that I am involved in and how our new Junior Rock Program progresses.

TID-BIT-PETRIFIED WOOD

Many pieces of petrified wood, especially from the Northwest, have a center that looks like wood, but with a layer of either chalcedony or pumice between the center and the outside. This indicates that the tree was green when it was hurried in the hot ash. The water in the green wood evaporated, making the wood shrink. The outside was made into a cast by the heat, so the area left between the wood and cast filled with chalcedony making, often, a beautiful piece of petrified wood.

I think that turquoise is special because it is rare. It displays vivid shades of green/blue. It has a chemical formula of $\text{CuAl}_6(\text{PO}_4)_4(\text{OH})_8 \cdot 4\text{H}_2\text{O}$.

In New Mexico, mines are sadly vanishing in localities that have been serving turquoise for thousands of years. The places in the United States for it are Nevada, Colorado and Arizona. It is a white mineral inside. It oxidizes (which is reacting with oxygen in the air).

Turquoise is special because it's rare. It oxidizes from white to blue/green. You can scratch its color off! It is not poisonous. It is a semi-precious mineral. It displays vivid blue/green shades.

If you polish it in the right way, it can be valuable but you can enjoy it raw, too. Turquoise is amazing.

SIXTH ANNUAL 2015 WEB SITE COMPETITION

It's time for YOUR club to plan to enter the 2015 SCFMS Web Site Competition! It only takes about 15 minutes for your webmaster to fill out the ONLINE entry form, to put information at the topes of the two ONLINE score sheet pages, save them to his or her hard drive, and then e-mail the two files to me at pgeorge4@comcast.net **by Sunday, March 1, 2015**. Please do not let the "far away" date lull you into a false sense of security----that might cause you to miss the deadline. :o(

This year this SCFMS is hosting the AFMS annual show, and it is scheduled for October 23-25, 2015. The March 1 due date allows the two SCFMS judges time to finish their thorough judging of all entries before the top three entries are forwarded to the AFMS Judge, Wes Lingerfelt. The results or **BOTH** the AFMS and SCFMS Web Site Contest will be announced during the Breakfast with the Editors and Webmasters October 25, 2015 in Austin, Texas. That is it in a nutshell.

I hope everyone reading this will encourage their club's webmaster to enter the contest. Their Web site will be better for having gone through the process of being judged. So how does a club webmaster enter the contest? The webmaster needs to download **THREE** files---a copy of the

2015 Entry Form, the 2015 Score Sheet, and the 2015 Score Sheet Guidelines from the AFMS Web site (www.amfed.org). Be **SURE** the files you download all have **2015** in their names. There are all **PDF** files that can be filled in and saved on your computer. At the time of this writing, those files are not yet on the Web site, but hopefully they will be there by the time you check for them.

Please make sure that you have installed a free copy of Adobe Reader 9 or later. Adobe Reader lets you fill in your information, save it, and have the ability to change some of your filled-in answers later if necessary. I urge you to use Adobe Reader for this task. Occasionally when another PDF maker is used, the filled-in blanks appear to be completely blank to the recipient. Not good! Adobe Reader 11 is now available for downloading at <http://www.adobe.com/products/reader>.

These forms are all PDF files. They can be filled out on your computer and saved to your hard drive. Fill out the one-page Entry Form completely, and fill out the top part of the Score Sheet of both pages. **When finished, e-mail both forms to me, Phyllis George (pgeorge4@comcast.net), no later than Sunday March 1, 2015**

VOICES FROM THE PAST DULL SLAB SAW BLADE

After years of dealing with apparently inferior diamond blades in my slab saw, I found out that it was not the fault of the blade at all. Years ago when we bought the slab saw it was set up to run the blade at about 1175 RPM. It turns out that this was much too slow for the newer blades. I replaced the drive pulleys so that the blade is now turning at 3450 RPM. The saw now cuts through even the toughest agate with no trouble at

all. If you have been having trouble keeping your slab saw blade cutting properly, check the speed of the blade and run it according to the manufacturers recommendations. It makes a BIG difference.

VOICES FROM THE PAST PAST PRESIDENT'S COLUMN

I have been asked to write something for the Federation Newsletter. Having been around the Federation when it was first organized, I feel that I can speak for the need of such an organization as we saw it back in those early days.

When the first Gem & Mineral Societies were started here in the south central part of the country, we had no rules to guide us in the competition we started between the members. Each club had their own rules and no two were alike. When two or more clubs got together to compete, it took a long time to decide on what rules would be used. We could see that some kind of a formal organization was needed to bring the clubs together so they could help each other. It was decided that a Federation of clubs should be started where each member club would retain control of its own internal affairs while giving support

to the other member clubs. It was important then, and it is important now that each club of the Federation should give maximum support to the other clubs of the Federation, wherever possible.

We certainly do not have to waste our energy fighting with nonmember clubs. Neither should we waste our energy supporting nonmember clubs, who by their own free will choose not to support us.

I would urge all the clubs in our Federation to encourage their member to support the shows and projects of each club in the Federation while leaving it up to each individual as to how they personally want to respond to the activities of the nonmember clubs.

Happy Friday, Editors! Below is the ALAA excerpt for this month. It's not quite directly concerned with rock-hounding, but it's a good example of the kind of federal behavior that ALAA is worried about. It reminds me of what happened to a member of our club here in South Bend who has a mining claim in one of the Western states. The BLM had closed all the roads in the area, so he couldn't get to his claim except by walking miles, and he would have had to carry anything out on his back. He tried talking to the BLM but no success. According to the mining laws, he is guaranteed access to his claim, but it took him several years, working through our local congressional rep, before he could get the BLM to agree to the law. Then they allowed him access, but refused permission to use any of the water on the claim. Without water, he can't mine. He's still paying his claim fees, but it doesn't look like he'll ever be able to work it again.

EPA SEEKS AUTHORITY OVER ALL US WATERS

Note: The EPA's authority over "waters of the United States" was legislatively defined as applying only to "navigable" waters. Recently the EPA proposed new rules which omit the word "navigable," thus placing under its authority ALL waters and waterways, even temporary waterways such as drainage ditches.

FROM THE CONGRESSIONAL RECORD: JUNE 25, 2014

Today, U.S. Senator John Barrasso (R-WY) called on the Senate to support his legislation to prevent the Environmental Protection Agency and the Army Corps of Engineers from finalizing their March, 2014, proposed rule which would significantly expand federal authority under the Clean Water Act (CWA).

Excerpted from Sen. Barrasso's remarks: I have very serious concerns about the EPA's proposed Clean Water

Act jurisdictional rule. . . . Through this recently proposed rule, federal agencies are attempting to expand the definition of "waters of the United States." They want to include ditches and other dry areas where water flows only for a short duration after a rainfall. The government wants to control even that. Federal regulations have never defined ditches and other upland drainage features as "Waters of the US." But this proposed rule does, and it will have a huge impact on farmers, on ranchers, on small businesses that need to put a shovel in the ground to make a living. . . . Congress never intended the Clean Water Act to be used this way."
