## President's Report for the 2025 SCFMS Convention

Don Shurtz, SCFMS President

I want to thank the Austin Gem and Mineral Society for their strong effort in preparing and hosting the 2025 SCFMS Convention. Their planning moved the Convention away from their show. Their show is in the Palmer Events Center in Downtown Austin. On the same weekend, Austin is hosting only one of two Formula 1 races to be held in the United States. To help avoid some of the downtown expenses (Hotel rooms at over \$300.00 per night and similar price increases for dining), the Convention will be held in their Club House in the northern part of Austin. They will also provide a shuttle service between the Convention site and their downtown show.

I am hoping for a good turnout at the 2025 Convention. For the 2024 Convention in Mesquite (Dallas), the number of Delegates who signed up was rather dismal. However, many clubs actually had representation at the Convention. For 2025, the number of Delegates who have signed up is also rather bleak. I am just holding my breath, hoping that the participation at the Convention will be better than the number of Delegate forms received portends. Because so few signed up for the Breakfast with the Editors and Webmasters and the Awards Banquet, participation will be limited. Whatever happened to the days when we could fill a room for these side events?

Because our Convention is later in the year, we can gain some insight into club and society participation in the SCFMS. Based on a report from the SCFMS Secretary, as of September 30 (the due date), only 18 clubs/societies have submitted their Dues and Insurance Form. Last year, we had 34 clubs, so only a little over 50 percent have rejoined. Hopefully, there were several forms still in the mail on September 30. Last year, we had a similar situation with a large number of clubs joining after the due date.

The most significant items for this year's Convention are the election of new officers and the passing of a budget for FY2026. According to our Constitution and By-Laws, we will have a quorum and can conduct business legally. Our definition of a quorum is those present at a regularly scheduled meeting.

## District VII Vice President Report Raymond Lynch

## THE HOT SPRINGS GEOLOGY CLUB Hot Springs, Arkansas

The Hot Springs Geology Club (HSGC) was founded 51 years ago in 1974. I have been a member of the HSGC for the past 26 years and have served as president, vice-president, treasurer, editor of the club newsletter for twenty-two years, and as SCFMS vice-president for District VII for 18 years. I continue to be the Editor of the Hot Springs Bulletin beginning my 23nd year. Our small club consists of approximately 20 local active members and many more non-active (not local) dues paying members. About 10-15+/- members attend the monthly meetings at any one time. We have long distant members in South Carolina, Louisiana, and Texas. Our membership includes: geologists retired from the Arkansas Geological Survey & from Weyerhaeuser, a college geology professor, a consulting geologist, and a geotechnical engineering geologist. The late well-known Arkansas amateur mineralogist Henry de Linde for whom the mineral *delindeite*, first discovered in Arkansas and the world (at the Diamond Jo Quarry, Magnet Cove) was for many years a HSGC member. The rare mercury mineral Artsmithite, so far found only in Arkansas, was named after the late Art Smith, another club member. Recently, two new minerals known to science and first discovered from Potash Sulfur Springs Arkansas, have been named (year 2021) for club members: the late geologist Don Owens (*Donowensite*) and retired geologist Mike Howard (*Mikehowardite*).

Our club newsletter, "THE HOT SPRINGS BULLETIN," is theme oriented to some aspect of Arkansas Geology of which there is much to report. Our club Bulletin is sent to our members as well as many more nonmembers by email (107+) in the hopes that it will keep those informed of club happenings and encourage membership. The Bulletin is also forwarded and redistributed by others. Subject matter has included: the Hot Springs area with its world famous thermal waters that gush from springs on the side of Hot Springs Mountain in Hot Springs National Park, the equally well known world famous clear quartz crystals that formed in the nearby Ouachita Mountains, the many unusual exotic minerals and rocks of the geologically interesting Magnet Cove Intrusive, the Potash Sulfur Springs locality, and the numerous micro minerals of Granite Mountain near Little Rock and the Martin Maretta quarry adjacent to Magnet Cove, quartz from Jeffrey Quarry, wavellite, variscite, bauxite, smithsonite and of course diamonds at the "Crater of Diamonds State Park", Blanchard Springs Caverns, the Buffalo National River, the Rush Zinc District, the Ponca Lead District, pink dolomite crystals and fossils to name a few. Other geological items of interest are included in the Bulletin from the state and world, current geological events and happenings, fieldtrips, and news and articles from other clubs, the SCFMS and AFMS. Recently, the 2024 contest for club newsletters, published the previous year 2023, won first place in the national contest thus bringing recognition to the "THE HOT SPRINGS BULLETIN" and the "THE HOT SPRINGS GEOLOGY CLUB".

Rock and Fossil Programs given at three out of town Library's for summer reading programs.


Furnished Petrified Palm samples to LA State Exhibit Museum for state fossil exhibit.

#### **UNIFORM RULES REPORT FOR 2024**

At the AFMS Convention in Billings, Montana, the Uniform Rules Committee decided to divide up the online version of the Rules into individual files, each containing one division of the rules. The current version is all one file, which is quite long and may contain more information than a potential exhibitor may need to have. This revision will make it easier for someone to download only the rules that pertain to the division in which he wants to exhibit.

Rules for all divisions will still be available online; the only difference is that they must be accessed and downloaded individually.

The revised rules for Division J (meteorites) will be included in the new version when it is published. Also, the Guidelines for Judges and Guidelines for Exhibitors handbooks are being updated to include these latest changes. At the Rocky Mountain Federation convention in Oklahoma City, we will discuss possible ways to encourage more competitive exhibits.

The SCFMS Website, <u>www.SCFMS.net</u>, is the official website of the South Central Federation of Mineral Societies. It exists to provide vital information to SCFMS clubs and Societies. It also provides information to the general public regarding SCFMS and Club/Society activities.

One of the duties of the Website Chair is to maintain the SCFMS domain name and hosting, ensuring the site remains available at all times. The domain name and website hosting were renewed in July 2025 for a one-year term. The domain name and hosting will expire in August 2026. The domain name and hosting were limited to one year to remain within the 2025 budget. It has been recommended that the SCFMS Budget for 2026 be increased to allow for the renewal of the domain name and hosting for multiple years.

The most important change to the SCFMS Website and Committee is that the Website Committee Chair and Webmaster is now Michael (Mike) Smith. Mike has been the Webmaster for the Paleontological Society of Austin, where he excelled in the SCFMS and AFMS Website Contest. The transition to the SCFMS Webmaster position occurred in August, with the updated website launching on September 2, 2025.
